Dr Collette Snowden

Dr Collette Snowden is a Senior Lecturer in the School of Communication, International Studies and Languages at the University of South Australia.

She previously worked as a journalist, media advisor, public relations practitioner, and as a consultant and researcher in the mobile communications and information technology sector.

Her academic research is focused on the uses and effects of new technology on the media and public communication, particularly on the communication and media industries, and women. Her work is informed by historical processes, social trends and political decision-making.



Dr Erica Millar

Dr Erica Millar is an interdisciplinary scholar who specialises in the history, sociology, and cultural politics of reproduction.

She has published widely on how cultural representations of reproduction work to regulate subjects in the current neoliberal period and reify structures of inequality, such as those pertaining to race, social class, and gender.

She has taught gender studies, sociology, and history across several Australian universities and is currently a lecturer in the School of Social Sciences at The University of Adelaide, Australia.
